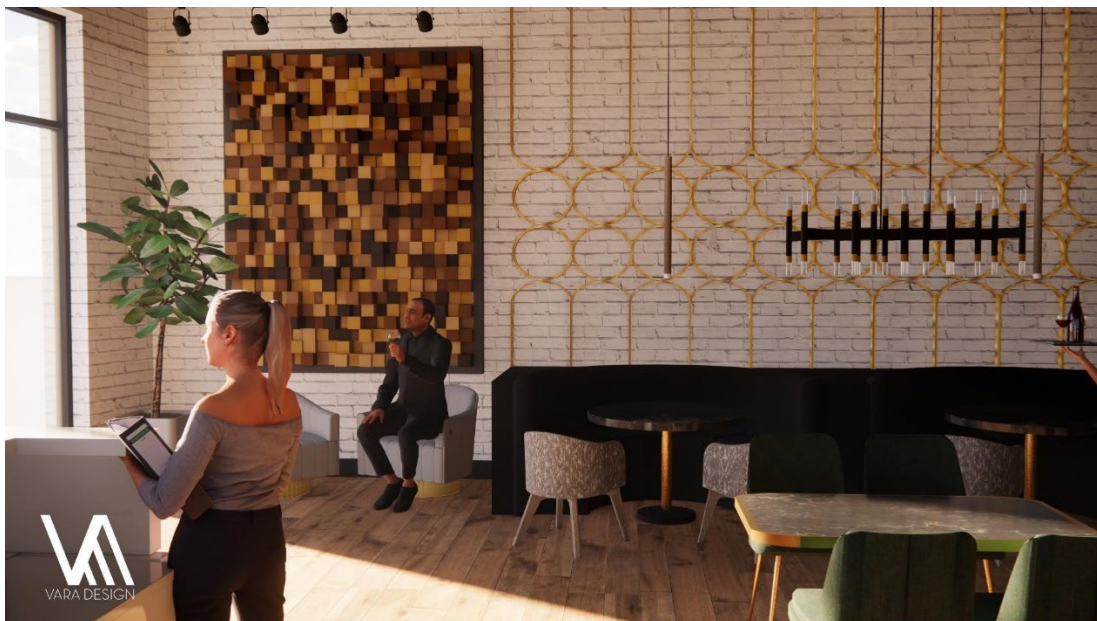

Floor plan for the Project

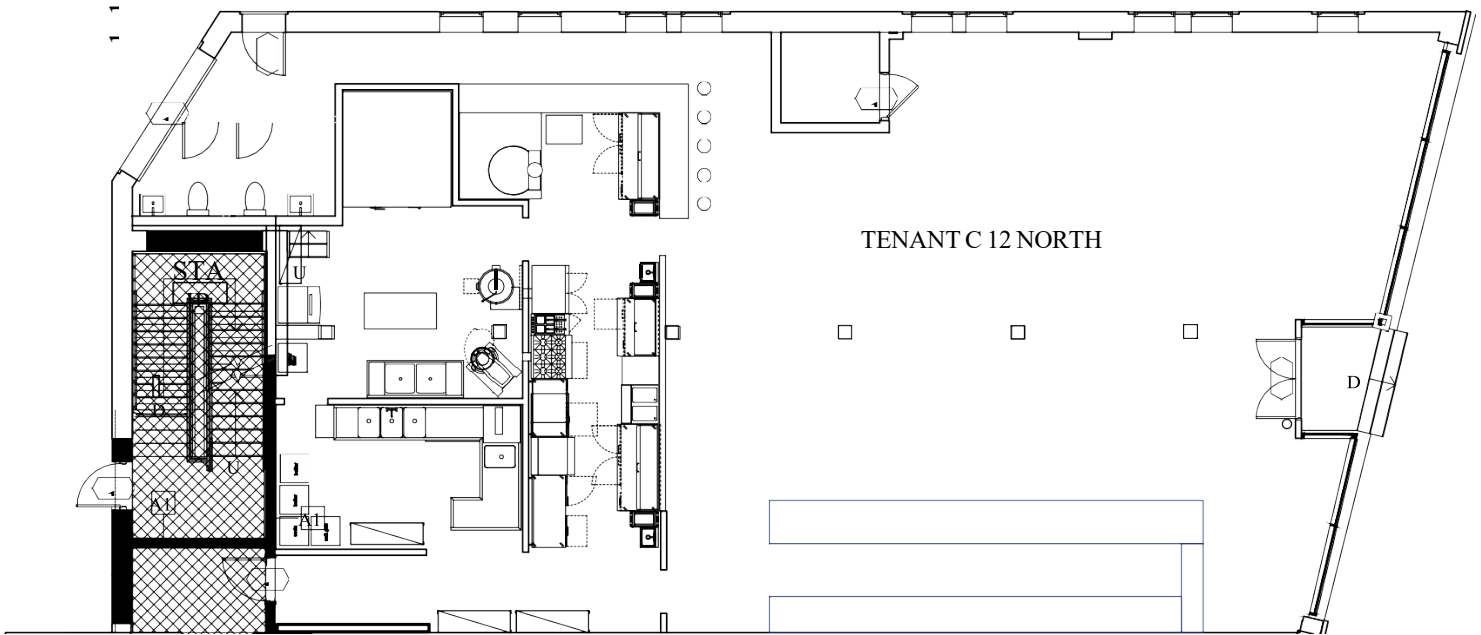
