THORNTONS INC. LIQUOR LICENSE DISCIPLINE

Thorntons' records on liquor licenses having been revoked only go back as far as May of 2001. To the best of the corporation's knowledge based on its records, Thorntons has not had any liquor licenses revoked.

Thorntons' records on liquor licenses having been suspended only go back as far as May of 2001. To the best of the corporation's knowledge based on its records, below is a list of its liquor licenses having been suspended:

- Thorntons # 41, Louisville, KY: On 07/11/2001, a CSR (CustomerService Representative/Cashier) sold alcohol to a minor. Fined \$1,000. The store served a 7-day suspension.
- Thorntons # 26, Louisville, KY: On 11/28/2001, an employee sold alcohol to a minor. Fined \$1,000, plus store employees had to complete TIPS training. The store served a 7-day suspension.
- Thorntons # 119, Lake in the Hills, IL: On 12/13/2001, an employee sold alcohol to a minor. Fined \$3,500. The store served a 5-day suspension.
- Thorntons # 36, Columbus, OH: On 01/13/2002, an employee sold alcohol on Sunday in violation of Sunday sales law. The store served a 1-month suspension.
- Thorntons #110, Indianapolis, IN: On 01/14/2002, Thorntons Inc.'s application for an alcoholic beverage license was denied at a public hearing due to opposition by the neighbors in the area.
- Thorntons # 139, North Aurora, IL: On 12/05/2003, an employee sold alcohol to a minor. Total fines \$2,000. The store served a 2-week suspension.
- Thorntons # 128, West Dundee, IL: On 12/20/2003, an employee sold alcohol to a minor. Fines and costs \$1,685.84. The store served a 3-day suspension.
