

Addendum No. 3

IT IS MUTUALLY AGREED that this jurisdictional transfer will become effective upon the day of opening two-way lanes of traffic on the reconstructed Illinois Route 31 (Lake Street) and the removal of the existing Illinois Route 31 route markings from Gale Street. Additionally, the staging of the construction shall be such that the Illinois Route 31 (Lake Street) portion must be completed and opened to two-way traffic prior to the route marking removal on Gale, River and New York Streets.
