The low base bid was submitted by Olsson Roofing Company from Aurora, Illinois in the amount of \$239,750.00. The second lowest base bid was submitted by L. Marshall, Inc. from Glenview, Illinois in the amount of \$297,000.00. See attached bid tabulation for details on bid results.

We conducted a Contractor Bid Scope Review with Olsson Roofing Company on May 25, 2021 and believe their bid to be responsive and complete.

Therefore, the City may wish to award a Contract to Olsson Roofing Company in the amount of \$258,250.00, which would include acceptance of Alternate No.1 (City Hall West Roof Area) in the amount of \$18,500.00.

Alternate #1:

1. Has addressed the crane time required to remove the abandoned equipment.
