

# CITY OF AURORA CERF PROGRAM

- The City has created three (3) different and distinct financial relief programs for our local businesses.
  - 1. No Liquor License Renewal Fees for On-Site Consumption Licenses for 2021-2022- approximately \$250,000
  - 2. Food and Beverage Tax Holiday for 90 days (in 2021) approximately \$1.0 million
  - 3. Direct Cash to Business Relief \$1.2 million

### PROGRAM #1: DIRECT CASH TO BUSINESS RELIEF

- This program allows the City to offer grants to reimburse a portion of business losses suffered as a direct result of the public health crisis, and assist as they adjust to the resulting business demands.
- The major qualifying expense used to determine the grant amount is "cost of business interruption," defined as the decrease in revenue.


