Hello Mr. Sieben,

In response to the increasing demand for wireless communications services, such as data and mobile phone services, T-Mobile has evaluated their coverage areas and found a coverage gap where the proposed antenna install is located at 325 S. Union St. in Aurora, IL. T-Mobile's RF Engineer has determined the site at 325 S. Union St. as the primary candidate due to both its height and central location within the search ring area to provide extended wireless coverage to the community.

The proposed antenna collocation site at 325 S Union St in Aurora, IL has been deemed Special Use following the DST Meeting. The proposed site shall consist of the installation of three (3) new antennas, one (1) GPS antenna, one (1) microwave dish antenna, two (2) system modules, three (3) RF modules, three (3) COVP's, two (2) Hybrid cables (one a microwave cable and one a coax cable for GPS), one (1) HP large site support cabinet, one (1) battery cabinet, and one (1) steel cube with modules all located within the new 17'-0" x 12'-0" T-Mobile lease area in the building's basement.

As a Special Use site, T-Mobile agrees to conform to the Standards for Special Use, as outlined in the City of Aurora's Code of Ordinances.


