

Christopher is an excellent complement to any collaborative team setting. And for this reason alone I see him performing well while interacting with cohort both locally and at Wharton.

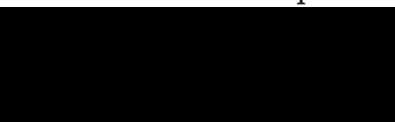
