Location: Avon St. and alley to east of 4th Street and North Avenue, S. Lincoln Avenue between Seminary Avenue and South Avenue, Jackson Street from North Avenue to Benton Street and Benton Street from Jackson Street to East.

Proposed Improvement: Installation of 3,400 LF of storm sewer ranging in size from 12" to 42", 37 storm structures, and other miscellaneous appurtenances all in accordance with the plans and specifications.
