- 9 ratified and confirmed.

- 12 The planning and zoning director shall serve as executive

- 16 director and his or her staff shall provide support to the
- 17 commission as needed.

- The commission shall:

- the provisions of the zoning ordinance, and to make reports
- of its recommendations to the mayor and city council.

- 29 pass under the Aurora Zoning Ordinance.
- 30 (4) Hear and pass upon applications for variations from the
- 31 terms provided in the zoning ordinance.

- (5) Hear and decide appeals from any order, requirement, decision, or determination made by the zoning administrator in accordance with the zoning ordinance.
 - (6) In all official proceedings, the chairman, or in his/her absence, the acting chairman of the planning and zoning commission, shall have the power to administer oaths and compel by subpoena the attendance and testimony of witnesses and the production of books and papers.
- 9 (7) Perform and exercise any additional function or power 10 vested in the commission by ordinance.
