This is an ongoing problem along Westbrook Dr. We do not currently have an ordinance to address this. Our commercial vehicle ordinance only deals with residential. I was also unable to find anything that would address the issue of parking of trailers without the tractor. I think this is something that we should look into when it comes to updating/changing the ordinance related to commercial vehicle parking.

In the meantime, would it be possible to propose posting No Truck Parking signs in this area? We have a couple of things that are happening. I'm being told we have 3 or 4 businesses that consist of a desk, chair and computer. These businesses are parking trucks here. There also appears to be independent truck drivers who are storing their trucks on these streets. We have written and towed a couple for 48 hour violations, however, as you can probably imagine it's a little more than just having a car towed.

Thanks for the photos and forwarded message. I am forwarding to Sergeant Woods for possible enforcement.

Westbrook Drive is not a residential roadway but is a roadway that serves commercial and industrial use, so it is not as restrictive toward trucks as a residential street would be. That being said, it is not legal to store a truck trailer on a City roadway. Would be beneficial to discover what business is generating the truck trailer parking and see if there is a solution, not park in front of the Dental Office. If no other solution is available, then signage with enforcement may become the viable option.

I will follow-up with Sergeant Woods to see what info APD can obtain regarding the parked trailer.
