AN ORDINANCE AMENDING CHAPTER 2, ARTICLE II,  
ENTITLED "STANDING COMMITTEES" OF THE CODE OF ORDINANCES  
FOR THE CITY OF AURORA

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals and welfare; and

WHEREAS, in furtherance of its home rule powers, it is necessary and desirable for the City of Aurora to amend its ordinances from time to time;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Aurora, Kane and DuPage Counties, Illinois, as follows:

Section One: That Section 2-123 of Article II of Chapter 2 be and is hereby amended as follows:

Sec. 2-123. Standing committees.

(a) Each standing committee shall have three (3) regular members and one (1) alternate member as provided in subsection (d) hereof. Each member of the city council shall serve on at least one (1) standing committee.

(b) \* \* \*

(c) The standing committees of the city council are as follows:

(1) The finance committee which shall have jurisdiction over all matters pertaining to taxation, city indebtedness, fees and service charges, management of the city's monies, the airport, the library and the city's operating, pension, insurance, motor fuel tax and capital budgets;

~~(d)~~ (2) The planning and development committee which shall have jurisdiction over all matters pertaining to annexation, planning, zoning, housing,

urban renewal, business and community development, ~~environmental matters~~, code development, and code enforcement and community development block grant administration;

~~(e)~~ (3) The government operations committee which shall have jurisdiction over all matters pertaining to intergovernmental relations, traffic and street lighting, elections, and legislative matters, the motor vehicle parking system, golf courses and transportation centers; and

(4) The environment and water quality committee which shall have jurisdiction over all matters pertaining to the environment, sanitation, solid waste, flooding, water treatment and distribution and storm and sanitary sewers.

(d) In addition to the three (3) regular members provided for in subsection (a) hereof, one (1) alternate member shall be designated for each committee pursuant to subsection (e) hereof. In the temporary absence or incapacity of a regular member of a committee, the alternate member thereof shall participate in and be allowed to vote upon actions taken by the committee at the relevant meeting or a portion thereof. Any regular member of a committee who anticipates being absent from a committee meeting must notify the committee's chairman and alternate member of such absence.

~~(f)~~ (e) The Mayor shall appoint the regular and alternate members of the standing committees with the advice and consent of the council. The Mayor shall submit a complete set of committee appointments at the first meeting following the qualification of council members after each municipal election, and the council shall vote for approval or disapproval of the committee appointments. If the council disapproves of the Mayor's appointments, those voting to disapprove shall state their reasons and the Mayor shall submit a reconsidered set of appointments at the next regular council meeting.

Section Two: That this ordinance shall be in full force and effect, and shall be controlling, upon its passage and approval.

Section Three: That all ordinances or parts of ordinances thereof in conflict herewith are hereby repealed to the extent of any such conflict.

Section Four: That any Section or provision of this ordinance that is construed to be invalid or void shall not affect the remaining Sections or provisions which shall remain in full force and effect thereafter.
