- ▶ Internal Communication Improvements
 - ▶ Automatic communications and personalized dashboards

 - ▶ Intuitive interface monitoring projects, applications, permits, inspections and violations from one screen
 - ▶ Greatly Expanded Self-Service capabilities
- ▶ Automatic Communications w/ Auto-Archiving
 - ▶ Triggered by change in status or by lapse of time

- ▶ Customer Self Service portal expanded to ALL divisions
 - ▶ Building & Permits - self service inspection scheduling portals have proven to increase CSR capacity by 13%, this has been as high as 25% during peak activity.
- ▶ Managerial Cross-Platform Oversight
 - ▶ Customized Dashboards

Current Legacy Solution

- Custom Separate Database for reporting purposes requires double entry
- Not visible to other divisions and data not portable to next process
- Virtually No Customer Transparency provided
- No Customer Self Service permitted
