DATE OF PASSAGE November 25, 2014

A Resolution Authorizing the purchase of (2) playground structures from GameTime c/o Cunningham Recreation of Naperville, IL for \$49,967.92 for the 6th Ward/Saville

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the City of Aurora was awarded a matching grant of \$42,917.47 from "GameTime" playground manufacturer to purchase two playground units for a total net cost of \$49,967.92; and

WHEREAS, these playgrounds will be installed in 2015 at property owned by the City in the 600 block of Iowa Avenue and at the northeast corner of Grand Avenue and Plum Street; and

WHEREAS, funds are available in account 316-4440-451.73-43 for this purchase in 2014; and

WHEREAS, pursuant to Aurora Code Section 2-335(a)(3) the desired product is provided by only one source in this situation;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, as follows: does hereby approve the purchase of (2) playground structures from GameTime c/o of Cunningham Recreation of Naperville, IL for \$49,967.92 for the 6th Ward/Saville and does hereby further authorize it's Purchasing Director to issue the necessary orders to implement purchase of the same.


