- Hand washing facilities.
- Three compartment utensil washing system.
- Dish soap and sanitizer.
- Food covered and stored off ground.
- Clean and sanitized cooking/serving utensils in adequate numbers.
- Dispensers for condiments.
- Clean trash can with lid and liners.
- Insect control.
- Cleaning supplies (broom, etc.).
- Packaged food info provided.
- Booth of approved construction.
- Containers for wastewater, grease, and charcoal (if applicable).
