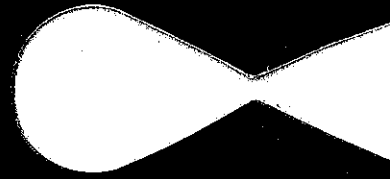
### ACKNOWLEDGEMENT AND HOLD HARMLESS
