- Per OSHA Regulations, we need to provide a spotter while any lift work is being done. This has to be an Advent employee. This is included in this quote.
- The receiver located at the head end location will be installed by Owner. A network connection from the RT25 head-end will be required at the receiver. This is not included in the quote. A final determination of mounting point will need further investigation.
