RE: COA-Animal Control Ring Extension/Re-route

Mr. Baker,

Thank you for the opportunity to submit the following proposal for the project referenced above.

## Scope:

- 1. Furnish and install approximately 5300LF of 1 1/4" polyduct via horizontal directional drill method from Prairie and Woodlawn to Animal Control.
- 2. Furnish and install (6) 36"x 60" composite type handholes (with blank covers) along new route.
- 3. Furnish and install (1) 36"x 60" composite type handhole over the existing duct package at Prairie and Woodlawn (blank cover)
- 4. Re-route (1) empty conduit into the new handhole at Prairie and Woodlawn.
- 5. Furnish and install mule tape in the empty conduit.
- 6. Furnish and install approximately of 5600LF of 144ct SMF cable from the newly installed handhole at Prairie and Woodlawn to Animal Control leaving 50FT slack coils at each handhole.
- 7. Furnish and install (1) 450D splice enclosure at the newly installed HH at Prairie and Woodlawn and prep newly installed 144ct cable.
- 8. During after hours maintenance window cut 144ct backbone cable at Prairie and Woodlawn and tie into newly installed 144ct cable and provide fusion splicing of (144) fibers.
- 9. Provide fusion splicing of (144) fibers at Animal Control FDP.
- 10. Provide OTDR and power meter testing from Animal Control to City Hall.
- 11. Provide test result package including OTDR and power meter results.
- 12. Restore turf areas with seed and blanket.
