Thank you for the opportunity to submit the following proposal for the project referenced above.

### **SCOPE**

- 1. Furnish and install approximately 900 LF of 1.25" polyduct with tracer and pull rope via horizontal direction drill method from HH 4-8 to Well 119 at Constitution and Downer.
- 2. Provide outside wall core into Well 119 and install outside box.
- 3. Furnish and install (1) 30"x48" blank handhole.
- 4. Furnish and install (1) locate pedestal with conduit tie to the handhole.
- 5. Furnish and install approx. 1,200' of 144ct SM Ribbon OSP cable from existing case at HH 4-8 to the new HH at Well 119 per design leaving slack coils at each new HH.
- 6. Furnish and install B case in HH outside of Well 119.
- 7. Provide fiber tags at each slack coil.
- 8. Inside Well 119, install plywood backer and mount loaded SPH panel on plywood.
- 9. Furnish and install 12ct fiber in HH outside Well 119 and into building and prep on both ends.
- 10. Prep cable in new case at new case at Well 119 and existing HH 4-8.
- 11. Provide fusion splicing of TBD fibers in HH 4-8, HH outside Well 119 and 12ct fiber at panel..
- 12. Provide pick up trucks, fusion splicer, capstans, trailer and splice trailer.

# **Testing**

- 1. Uni-directionally OTDR test (144) fibers from HH 4-8 to new HH outside Well 119.
- 2. Plug in loop back jumpers in fibers tbd and confirm link with COA.
- 3. Provide pick-up trucks, OTDR and power meters.
- 4. Provide test results package upon completion.

- 1. Provide labor to audit all new handholes as well as existing handholes that were used for the project.
- 2. Provide pictures and details of each handhole.
