Insurance must be in an amount not less than \$1,000,000 covering public liability and not less than \$500,000 covering public damage, such policy insuring liability that may arise from the operation or maintenance of the music festival or any part therof.		
Performance Bond or a certified check in the amount of \$1,000 . A performance bond is required to guarantee the restoration of the premises.		
The Applicant shall restore the premises to the same condition as premises existed prior to the operation of the music festival, including or any part therof, trash, garbage and miscellaneous debris, and to insure the performance of these acts the performance bond is required.
