CITY OF AURORA SPECIAL CENSUS UPDATE SHANNON CAMERON, CHIEF OF STAFF - MAYOR'S OFFICE



OVERVIEW


- The City of Aurora was scheduled to complete a Special Census beginning on February 3, 2025
- The effort arose after the City was said to have lost approximately 17,000 people during the 2020 Census, resulting in a loss of \$4.3 million per year in revenue
- With the inauguration of the new Presidential Administration, a Federal hiring freeze was enacted, effectively preventing the City from conducting the Special Census
- The Census Bureau has received a temporary hiring waiver, allowing the agency to hire temporary field staff to support the Special Census Program in calendar year 2025 only
- As a result, the City of Aurora is currently scheduled to begin the Special Census on August 1, 2025, with field enumeration set to begin in mid to late-August
- With this expedited timeline, the City is contemplating whether to proceed with the August 1 date, delay the Special Census, or withdraw from the Special Census altogether




TIMELINE & LOGISTICAL REALITIES

- The Special Census will begin on August 1, 2025, but the Internet Self Response (ISR) Period will begin on July 1, 2025
- The deadline to hire temporary workers for the Special Census is December 31, 2025








OPERATIONAL CHALLENGES

Time Constraints

- The City has less than one month to build community awareness and public trust
- Currently, the City has only one full-time staff member in the Community Engagement Division
- Today, the City has a limited resource capacity due to the Mayoral transition and 2026 budget planning

Recruitment and Staffing

- Per the Census Bureau, 53 local Census workers must be hired to complete the Special Census
- The City had 22 past applicants who qualified, but current interest from them is unknown
- Internal staffing gaps exist: The City had access to more resources in the past, including a Harvard Fellow, a team of interns, and several team members with institutional knowledge on the Special Census
- The City's contracted Special Census consultant, Joan Cameron, is still available for utilization



OPERATIONAL CHALLENGES

Community Barriers

- Recent sightings of ICE and fear of Federal officials is prevalent
- Strong messaging in immigrant communities to **NOT** open doors
- Language access issues/barriers
- Partnerships with school districts are not available, as the Special Census will take place during the Summer months
- Locked apartment buildings make in-person outreach difficult

Risk of Undercount

- After completing the Special Census, if the City's count decreases, the certification can lower the population count, leading to more revenue loss
- If the Special Census is not complete by December 31, the City forfeits the remaining time and resources, meaning that the count could begin, but may not finish



RESOURCES & STRENGTHS

Budget Status

- The City paid the Census Bureau about \$1 million to complete the Special Census, and the Bureau has spent less than \$100,000
- The City has an ad credit with Univision Media for \$40,000, conducted outreach in the past in anticipation of the February Special Census, and has relationships with some community organizations to get messaging out

Communication Readiness

- Messaging, materials, and a communication plan have already been developed
- Digital advertisements are ready to launch (two-week lead time needed to push ads on Univision and Telemundo)

Existing Support

- Census Consultant Joan Cameron can provide immediate assistance
- Some local applicants, related to field enumerators, may still be available to work for the Special Census



OPTIONS FOR CONSIDERATION

Option 1: Proceed with August 1 Start

- PROS: The current plan will continue, resulting in no delays from the Census Bureau, and certain infrastructure is already in place to support the initiative
- CONS: A high risk of an undercount exists due to current barriers, limited time and staff, and the potential for wasted resources

Option 2: Request Delayed Start

- **PROS:** More time is available to organize, recruit job candidates, and build public trust
- CONS: The December 31 hiring cut-off reduces the amount of time available to conduct the Special Census, and there exists no guarantee of availability for a new date

Option 3: Request To Re-Enter The Queue

- **PROS:** Preserves the opportunity for a future attempt at completing the Special Census
- CONS: The Special Census will likely be postponed beyond 2025, and the future window in which it will occur is very uncertain

Option 4: Withdraw From The Special Census

- PROS: The City will receive its approximately \$900,000 from the Federal government and avoid the risk of a lower count
- CONS: This loses the opportunity for the City to potentially increase its population count, and, in turn, its yearly revenue



KEY CONSIDERATIONS FOR THE COUNCIL

- 1. Is our City positioned to effectively and equitably implement this count?
- 2. Can we ensure that hard-to-count populations will be included?
- 3. Are we willing to accept the risk of a lower certified population?
- 4. Is it fiscally responsible to proceed given the City's current staffing and capacity?
