SUBJECT:

Resolution requesting approval of an addendum to an existing Network Infrastructure Managed Services contract from Scientel Solutions LLC., 2021 N Eola Rd, Aurora, IL 60502.

PURPOSE:

At the time of the award of R21-136, the City was maintaining two physically distinct computer networks with two distinct fixewall infrastructures and configurations and the decision was made to exclude fixewalls from the award until the new, unified network topology was fully defined. Now that the new network is complete, this resolution will bring fixewall maintenance into the existing contract.

BACKGROUND:

The Scientel agreement approved in R21-136 also includes network design, planning, procurement, monitoring and installation of devices which is not included in the former Cisco agreement. This agreement was approved as a three year term with optional two 1-year extensions upon mutual consent. The optional first year was offered and accepted in March 2024.

At the time of the approval of R21-136 it was unknown how many firewalls would remain on the newly designed unified network. Now that the networks have been merged and migration to Fortinet devices has been completed amending the contract approved in R21-136 to ensure firewall devices are covered along with all other network devices is cost-effective.

A network firewall is a security system that controls the incoming and outgoing network traffic based on predetermined security rules. It acts as a barrier between a trusted internal network and an untrusted external network, like the internet. By filtering traffic, it

helps prevent unauthorized access and potential threats from reaching your network while allowing legitimate communication to pass through. Firewalls can also be configured to protect against various types of cyber threats and attacks.

DISCUSSION:

After a competitive bidding process, City IT staff selected Scientel Solutions the Network Infrastructure Managed Services partner. Scientel's Solution offered an efficient, cost-effective, and risk-reducing approach for the City.

Scientel's global headquarters based locally in Aurora, IL is home to a 24x7x365 Network Operations Center (NOC) with a world-class dispatch process. Scientel has integrated all City networking equipment into Scientel's 24x7 NOC for monitoring to ensure that all networking equipment is operating effectively

As defined in the Illinois Prevailing Wage Act, a Certified Transcript of Payroll will be provided to the City for all applicable work completed within this program.

Based on the last year of the true up submitted in 2023 (R24-009) the cost was to be \$901,250 annually, the proposed amendment will add annual fees of \$109,833.20 to the existing contract for a new annual total of \$1,011,083.20.

Funds are available in Account Number # 101-1280-419.38-26 to pay for this purchase.

As part of the City of Aurora Technology Strategic Plan or "IT Roadmap", the Information Technology Department is seeking to evaluate and improve efficiencies throughout the organization. This purchase is aligned with the Strategic Plan.

2. EXECUTIVE SUMMARY

Due to the growth and prosperity of the City of Aurora, the IT infrastructure supporting the daily government operations has continued to grow. The current network infrastructure has grown larger than what is currently defined in the Network Managed Service contract. Additionally, cyber and network security considerations have created a need for additional consideration for the firewall devices included in the network that were not previously included in the current contract. Addressing this growth is important to sustain the success and future growth of the City of Aurora IT infrastructure.

This proposal extends the economies of scale of the current contract and provides the City of Aurora with continued support and services for their IT network devices for the life of the current contract and subsequent extensions. These modifications will allow the network to remain in full support and with continuous operation for the foreseeable future.





3. PROPOSED ADDENDUM

a. FIREWALLS UNDER MANAGEMENT ADDENDUM

Included below is the recommended addendum to include support and maintenance through the remaining life of the contract for Fortinet Firewalls that are owned by the City of Aurora.

This support and maintenance scope of services will include:

- Ongoing engineering support to actively manage and change firewall settings, rules and policies as required and requested by the City of Aurora and with review and approval in project team meetings.
- Continuous software maintenance and support with up to date Forticare subscriptions
- Regular backups conducted and stored in a secure, off-site location
- Continuous device monitoring on a 24x7 basis from Scientel's Aurora based Network Operation Center
 - Monitoring will include alerting on device availability and notification of any failures within 15 minutes of a detected outage

SUBJECT:

PURPOSE:

The City of Aurora's Network Infrastructure is managed by the IT Division and consists primarily of city-owned hardware and a maintenance contract through Cisco SmartNet. The SmartNet maintenance contracts ended in Feb/Mar 2021, and various devices have reached end of support and are targeted for obsolescence and or replacement.

BACKGROUND:

The City sought a strategic and trusted partner to help support the network technology infrastructure. The selected partnership would include support, maintenance and monitoring of existing infrastructure as well as professional services to develop and implement a network lifecycle management plan, create effective and secure services, and evolve with the City's changing infrastructure needs.

DISCUSSION:

In 2016, the IT Division received Council approval to enter into a five (5) year SmartNet maintenance agreement with Cisco that totaled \$2,159,885. Since 2016, the IT Division has received Council approval for purchase of new and replacement Cisco equipment totaling \$1,034,753. This 5-year total spend of \$3,194,638, equates to a \$638,928 average annual spend on equipment, services and support.

By selecting a Network Infrastructure Managed Services partner, the City reduces the risk of running network equipment beyond end of life as well as reduces annual expenditures to an average annual spend on equipment, services and support. If all 5 years of this agreement were to be executed, the average annual spend would be \$371,640. This would result an annual average savings of \$267,288 and a 5-year savings of \$1,336,440 if the current contract was extended at the rate of increase shown in the previous four years.

City IT staff maintains accountability and control of the network traffic and is responsible for overall network performance. With this agreement. City IT will have a co-partner to help manage physical components and develop network enhancements as the requirements of the City's network continue to expand over time.
