Mr. Baker,

Thank you for the opportunity to submit the following proposal for the project referenced above.

SCOPE:

1. Furnish and install approx. 180 LF of 1"1/4 polyduct via directional bore from new HH location to the Bus Stop Kiosk location HH 31-3.5.
2. Furnish and install (1) 24 x 36 HH and remove existing small HH.
3. Furnish and install concrete foundation for traffic cabinet.
4. Install COA provided traffic cab on new foundation.
5. Tie traffic cabinet and new HH together with 1"1/4 polyduct.
6. At HH 31-3.5 remove asphalt and concrete as needed to access HH.
7. Repair asphalt and concrete as needed.
8. Furnish and install approx. 225' of 12ct SMF from HH 31-3.5 to new HH location leaving slack loops at each HH location..
9. Furnish and install (1) loaded SPH wall mount panel in traffic cab.
10. Prep new 12ct cable at the new traffic cab location and provide fusion splicing of up to 12 fibers.
11. Pull existing case from HH location 31-3.5 and prep new 12ct cable.
12. Prep new 12ct cable at the HH and provide fusion splicing of up to 12 fibers.
13. Provide OTDR and Power meter testing from City Hall to traffic cab.
14. Provide test results package including OTDR traces and PM results.
15. Provide new audit package on the new HH and updated audit package of HH 31-3.5.
