A second amendment was offered by Alderwoman Baid, seconded by Alderman-at-large White to add additional language on page 1-2 following line 22 under Sec. 40-2 Scope, the language is as follows: Nothing in this Chapter shall be construed to guarantee the safety of any individual, nor shall this Chapter be construed to impose any duty of care, special relationship, or liability on the City of Aurora, its officials, employees, officers or agents. -- The amendment passed via roll call vote with 5 yes, 0 no.

A third amendment was offered by Alderwoman Baid, seconded by Vice Chair Barreiro to change on page 2, lines 6-7 the words shall to may. This amendment failed by roll call vote with a vote 1 yes, 4 no.
