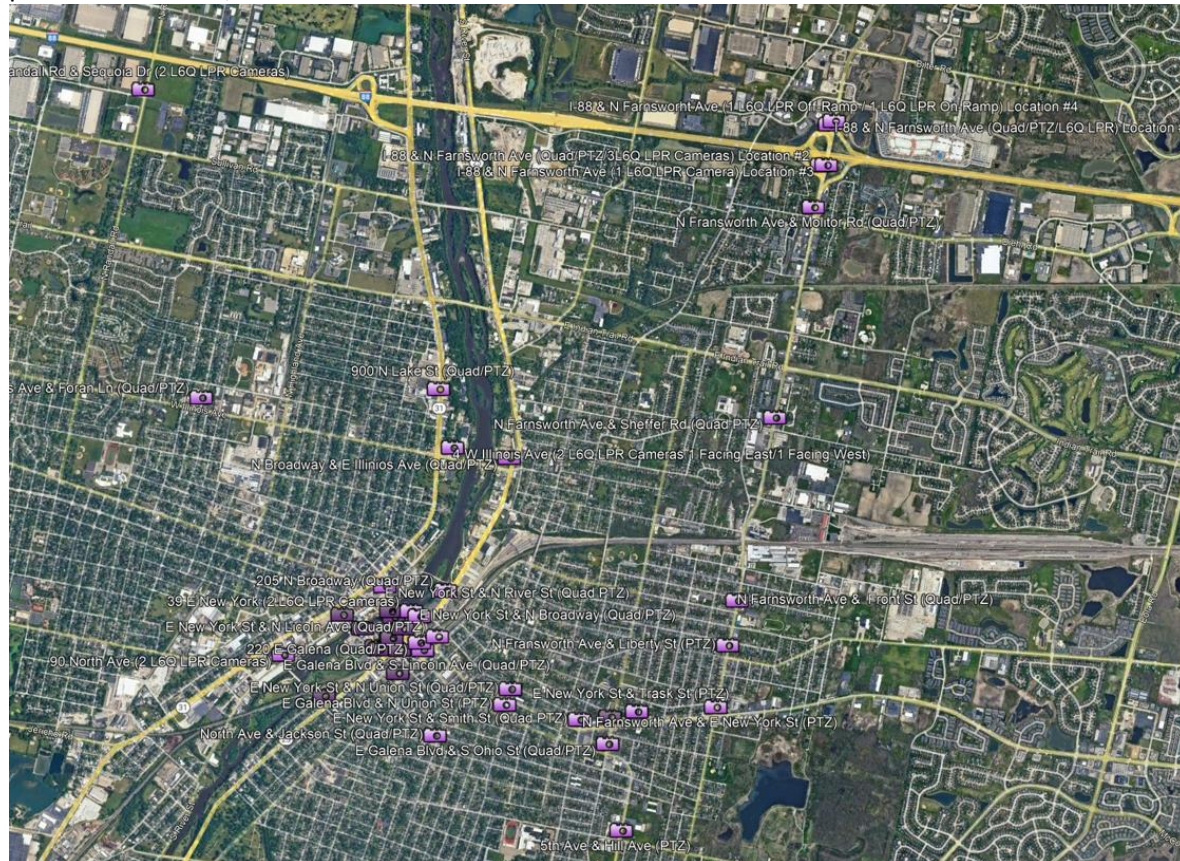

Description of Work / Scope of Services

Scientel Solutions has engineered a Situational Awareness Camera solution to help ensure the ongoing safety and protection of the Broadway Corridor and the outlying areas that have been affected by civil unrest. To achieve better situational awareness in the Broadway Corridor, the City of Aurora is proposing to install the latest in Digital Video Cameras and License Plate Recognition Cameras. One of the benefits of an improved video coverage is the ability to prevent future damage to private and public property because of civil unrest. This solution provides live video coverage which will better equip Aurora's first responders with the most up to date information. In addition to the prevention of damage, this solution will allow our public safety officers to review and investigate metadata from previous incidents/situations.



The system consists of the following:

- (26) Axis Q6100-E (quad 5mp fixed camera) and (26) Axis 2mp Q6075-E PTZ camera integrated into the same housing. This will provide our public safety officers with a complete 360-degree Field of View (FOV) as well as the ability to zoom in and get real time detailed information with the integrated PTZ facilitating the overall Situational Awareness for the officers protecting our community.
 - (6) AXIS Q6135-LE PTZ only at 6 locations
 - (21) Motorola L6Q License Plate Cameras (LPR) to cover the bridges entering or existing the Broadway Corridor. This will provide detailed tracking of license plates in and out of the downtown Aurora area. These cameras will fully integrate into Aurora's existing Genetec AutoVu VMS and LPR Manager. This will provide the provide our public safety officers with detailed license plate metadata for postmortem analysis.
 - (8) link radio backhaul system to provide connectivity at locations not currently supported
- Procurement Services
 - Scientel will procure all equipment listed above for the camera system and radio backhaul.
 - Staging & Installation Services
 - Scientel will receive, inspect, and catalog all the new equipment at our Aurora HQ.
 - All devices and pertaining information (Model and Serial #, IP address, location) will be incorporated into the existing camera tracker and inventory for Aurora's Camera System
 - Cameras will be configured and named in according to existing practices and in conjunction with requirements made by the Aurora PD.
 - The installation will be coordinated around the availability of power and new poles where applicable and provided by others.
 - Closeout & Ongoing Maintenance:
 - Scientel will provide Aurora with a closeout package which will include:
 - Installation photos & testing results
 - Documentation with equipment information such as serial #'s, IP Addresses, login credentials, and warranty information.
 - Following installation, cameras will be maintained under the current Maintenance & Support agreement with the city.
