- Members of the Planning and Zoning Commission;
- Appointed administrative staff of such boards and commissions:
- All persons employed in Executive Service positions, as set forth in the City pay plan.

The term, "controlling" as used hereinafter is defined to mean non-ownership control.

The term, "minor children" refers to children under eighteen (18) years of age unless emancipated.

Section 2-185(e)(1) of the City of Aurora Code of Ordinances, requires the City Clerk to provide the ethics adviser with a list of persons covered by this ordinance as well as a copy of each of their respective disclosure statements for review by the ethics adviser. The Clerk shall also provide the ethics adviser with a list of any covered persons who failed to comply with the requirements of this section.

Section 2-185(e)(2) of the City of Aurora Code of Ordinances states, "any covered person who willfully fails to comply with the requirements of this Section by May 31 of any calendar year or within thirty (30) days of his or her appointment or employment with the City commits a violation of the City of Aurora Ethics Ordinance. Any covered person who willfully submits a disclosure report he or she knows to contain false or materially incomplete information commits a violation of the City of Aurora Ethics Ordinance."
