Mr Baker,

Thank you for the opportunity to submit the following proposal for the project referenced above.

Scope

- 1. Julie route and establish location of all utilities.
- 2. Provide engineering and permits to cross BNSF RR north of Jericho.
- 3. Furnish and install approx. 4100' of 1.25" poly duct with tracer and pull rope via directional bore.
- 4. Furnish and install (4) 30" x 48" HH outside of Well 19.
- 5. Furnish and install (4) locate ped at new HH.
- 6. Furnish and install approx 4700' of 144ct OSP SM FOC from Well 115 144ct lateral to existing HH with slack coils in each new HH along the route.
- 7. Pull existing back bone 144ct cable into trailer, perform midsheath, prep in new 144ct cable and perform fusion splicing of fibers TBD.
- 8. Create new SEP's for new HH's and update existing SEP's.
- 9. Clean up and remove all debris associated.
- 10. Provide as-builts upon completion.
- 11. Repair turf with seed and blanket.
