
3. Scope of Services






Scope of Services – Aurora Animal Control Access Control System: Scientel/Siemens to provide a solution for access control system at Aurora Animal Control Center facility (600 South River Street). Siemens to perform a migration of customers' current access control system to Genetec. Siemens will work with the customer on migrating existing hardware over to the new system to mitigate any loss of functionality for the least amount of downtime possible if applicable. The proposal includes all hardware included on the equipment list page as well as full installation and commissioning.

- Siemens electrical contractor to supply and install cable for 6 card reader doors based on customer provided print.
- Exterior doors will receive a card reader, rex, door contact and locking hardware cable.
- Interior doors will only require a card reader and locking hardware cable.
- Supply and install cable at 1 existing exterior door locations based on customer provided print for a full card reader installation (reader, rex, door contact, strike).
- Supply and install raceway (wiremold may be required) for card reader, strike wire and door contact.
- Remove existing card access panel, power supply and enclosures. Install new rack, card access panel and
- power supply.
- Install raceway where required into drop ceiling from panel. Terminate wiring at the panel location.
- Provide 120V power utilizing the local power.
- Install field devices and connect to door strike provided by others for the 12 card access doors.
- Assist in testing once programming has been completed by Siemens.
