such policy insuring liability that may arise from the operation or maintenance of the music festival or any part thereof.

## Restoration of premises:

Applicant shall restore the premises to the same condition as premises existed prior to the operation of the music festival, including or any part thereof, trash, garbage, and miscellaneous debris, and to insure the performance of this Article, the applicant shall submit, prior to approval of any application hereunder, a Performance Bond in the amount of not less than \$1,000 guaranteeing the restoration of the premises as provided herein.
