## 3. Scope of Services

#### **Project Kickoff / Detailed Design Review:**

- Scientel will provide a Project Manager to oversee the project entirely, including scheduling project kickoff, ordering of equipment, scheduling of technicians, and arranging the installation process.
- Determine Equipment location and confirm power requirements
- Determine facility access requirements and Work Hours
- Develop Acceptance Testing Plan for all phases of each implementation to determine success/fail criteria.
- Deliverable:
  - Detailed Design Review Document encompassing above items

#### Scope of Services – Aurora WTP (1111 Aurora Ave):

Scientel to provide a turnkey solution for access control system at Aurora WTP facility located at 1111 Aurora Ave. We will perform a migration of customers' current facility commander system. Scientel will work with Aurora on migrating existing hardware over to the new system to mitigate any loss of functionality for the least amount of downtime possible if applicable. This proposal includes all hardware included on the equipment list page as well as full installation and commissioning (including locksmith work for the Main Building 2nd Floor IDF Room only).



- Scientel or electrical contractor to supply and install conduit and cable system for 1 new card reader on office door to nearest card access panel at Main Building.
- Install new card access panels and power supplies at 2 separate locations utilizing the existing enclosures inside the building and at 2 separate gate locations utilizing the existing enclosures.
- Terminate wiring at the panel locations & Provide 120V power utilizing the local power.
- Install new remote card access boards above card access doors, new card readers and connect wiring from door devices to new boards.
- Connect existing inputs for any individual door contacts in the field. Assist in testing once programming has been completed.
- Utilizing existing fiber connect to media convertors and install CAT6 cable to video intercom door stations, use existing raceway at the 2 remote gates for the CAT6 connection.

# Scope of Work – Indian Trail Water Tower, Bilter Road: (Well 20), Barnes Road, Phillips Park, Church Road Park, Fox Valley Park

- Install new card access panels and power supplies at 2 separate locations utilizing the existing enclosures & new remote card access boards above card access doors.
- Identify wiring from main panels to each remote panel location. Terminate wiring at the panel locations & Provide 120V power utilizing the local power.
- Connect existing inputs for any individual door contacts in the field. Assist in testing once programming has been completed.
- Each site listed above will require the following work completed by Scientel or electrical contractor.
  - (X1) Reader Swap-out
  - o (X1) Controller, Interface Modules, Power Supply and Enclosure replacement
  - o EC will supply all misc. hardware required to complete the panel replacement.
  - EC will be utilizing the existing 120V power and network connection and all existing wiring at all sites that have been installed by others.



### 4. Exclusions & Clarifications

#### Clarifications, Exclusions & Assumptions

- 1. Network Provided by Aurora
- 2. Any network switch hardware provided by Aurora
- 3. Painting and patching is not included in this proposal
- 4. Two (2) SFP Modules is not included in this proposal
- 5. For all current doors, we will be utilizing existing wiring.
- 6. Pricing includes one (1) year warranty on materials only.
- 7. Materials pricing is for the extent of the tentative project schedule.
- 8. Pricing includes standard ground shipping.
- 9. Scope of work allows for coordinated scheduled deployment and site access, any interruptions to project schedule may be subject to change order.
- 10. All work is to be performed during regular business hours, I.E. 8AM-5PM, Mon-Fri.
- 11. Customer is responsible for any license or permit fees required by local ordinance.
- 12. All pricing excludes shipping and taxes
