Review Comments: The materials submitted have been reviewed and a few items have been found that need to be addressed, requiring a subsequent submittal and review. This re-submittal (in paper and digital form), should be delivered to the Planning and Zoning Offices by **October 3, 2018**.

- A. Please include the following changes to the **Final Plan** document submitted:
 - 1. The dimensions should be shown on the plan in accurate **engineering** scale.
 - 2. Remove "for address plat for Aurora University 2nd Resubdivision 503 Spaces City of Aurora Kane County Illinois" in the title of Final Plan.
 - 3. Please relocate the sidewalk at the corner of Prairie St and Randall Rd extended so that the fire hydrant is not on top of the sidewalk.
- B. Please include the following changes to the **Final Plat** document submitted:
 - 1. Move the Owner's name and address and the Original and revision dates into the Title Bar or Block.
 - 2. Change the title of the proposed City Easement over the area of Southlawn Place to "CITY EASEMENT HEREBY GRANTED"
 - 3. Change the label over the area of Southlawn Place that is being vacated to "SOUTHLAWN VACATED BY DOCUMENT ______.".
- C. Please include the following changes to the **Landscape Plan** document submitted:
 - 1. The Landscape Implementation Data Table: Plant List by Category should be add to the Plan
 - 2. Label all plant material with the Plant Symbol.
 - 3. A total of the 190 shrubs should be install to meet the <u>Foundation</u> planting requirement for the parking deck. Please use a variety deciduous and evergreen shrubs:
 - a) Replace the 120 blue hosta along the north side of the parking lot with 63 shrubs for a total of 70 shrubs.

- b) Add additional 14 shrubs along the south side of the deck for a total of 70 shrubs.
- c) Add an additional 13 shrubs along the west side of the deck for a total of 25 shrubs
- d) Add an additional 12 shrubs along the west side of the deck for a total of 25 shrubs
- D. Please include the following content changes to the Building and Signage Elevations document submitted:
 - 1. Remove "for address plat for Aurora University 2nd Resubdivision 503 Spaces City of Aurora Kane County Illinois" in the title of Final Plan.
- E. Please include the following **content** changes (pursuant to Format Guidelines 2-1) to the **Street Name** and Address Plat document submitted:
 - 1. Move the Owner's name and address into the Title Bar or Block.
 - 2. Add the full address for the Centennial hall building pad at 1363 Prairie Street.
- B. Please include the following <u>content</u> changes (pursuant to Format Guidelines 2-1) to the <u>Plat of Vacation</u> document submitted:
 - 1. A label (in a large font) of "City Ordinance: _____ Passed on: ____ " should be added near the upper right-hand corner of the first page of the plat. (Sec. 1.7)
 - 2. Move the Owner's name and address & Original and revision dates into the Title Bar or Block
 - 3. Add the bearing to the external boundary at the vacation.
 - 4. Remove the arrow and label "Hereby Grant a City Easement" as this is being granted on the Plat of Resubdivision.
 - 5. Remove the City Easement Provisions as this is not needed.
