Sec 6-2 Definitions

- 3 All words and phrases used in this chapter, not otherwise defined
- 4 herein, and which are defined in The Liquor Control Act of 1934
- 5 (235 ILCS 5/1-1 et seq.) as now or hereafter amended, shall have
- 6 the meaning accorded to such words and phrases in such act. Unless
- 7 the context otherwise requires, the following terms as used in
- 8 this chapter shall be construed according to the definitions given
- 9 below:
- 10 Synthetic cannabinoid as defined in Chapter 29 of the Code of
- 11 Ordinances.
- 12 Tetrahydrocannabinols (THC) mean those substances contained in a
- 13 plant of the genus of Cannabis (cannabis plant), as well as
- 14 synthetic substances, derivatives, and their isomers with similar
- 15 chemical structure and pharmacological activity to those
- 16 substances contained in the plant.
- 17 Tetrahydrocannabinol products means a product which contains THC
- 18 including but not limited to such products as delta 8, THCA, THC-
- 19 O vapes and food products such as gummies, bars, ice cream.

Sec 6-27 Prohibited Products

- 22 (a) It shall be unlawful for any person holding a liquor
- license to sell at retail for consumption off the premises
- 24 where sold, any single can, bottle or other container

- holding beer or wine that contains sixteen (16) fluid ounces/four hundred seventy-five (475) milliliters or less which is refrigerated or displayed in ice.
- 4 (b) It shall be unlawful for any person holding a liquor
 5 license to sell at retail any single container holding less
 6 than seven hundred fifty (750) milliliters of wine where
 7 alcohol content determined by volume exceeds thirteen (13)
 8 percent.
- 9 (c) It shall be unlawful for any person holding a liquor
 10 license to sell at retail any alcoholic liquor where
 11 alcohol content determined by volume exceeds seventy-six
 12 (76) percent.
- 13 (d) It shall be unlawful for any person holding a liquor
 14 license to sell at retail any single can, bottle or other
 15 container holding malt liquor that contains more than
 16 twenty-four (24) fluid ounces.
- 17 (e) It shall be unlawful for any person holding a liquor
 18 license to sell or give away items of drug paraphernalia,
 19 as defined in section 29-302 of this Code.
- 20 (f) It shall be unlawful for any person holding a liquor
 21 license to sell products used to roll tobacco into
 22 cigarettes, commonly referred to as rolling papers or
 23 cigarette papers.

- 1 (g) It shall be unlawful for any person holding a liquor
 2 license to sell or give away, for use off the premises,
 3 individual paper, plastic or other disposable-type
 4 beverage cups.
- 5 (h) It shall be unlawful for any person holding a liquor
 6 license to display for sale any adult magazine, book,
 7 poster, or electronic media in such a manner that it can
 8 be viewed by those under the age of eighteen (18).
- 9 (i) It shall be unlawful for any licensee or any employee or

 10 agent of any such licensee to sell, deliver, or distribute

 11 any product which contains Tetrahyrdocannabinol (THC) or

 12 any synthetic cannabinoid.
