

EXHIBIT A INTERGOVERNMENTAL AGREEMENT FOR TEMPORARY CONSTRUCTION ACCESS

THIS INTERGOVERNMENTAL AGREEMENT (the "Agreement") is made and entered into as of the _____ day of ______, 20__, by and between the FOX VALLEY PARK DISTRICT, an Illinois municipal corporation (hereinafter referred to as "FVPD") and the CITY OF AURORA, an Illinois municipality (hereinafter referred to as the "CITY").

WITNESSETH:

WHEREAS, Article 7, Section 10 of the Constitution of the State of Illinois, 1970, authorize units of local government, including park districts and municipalities, to enter into agreements to exercise, combine or transfer power or functions not prohibited to them by law or ordinance; and

WHEREAS, the Intergovernmental Cooperation Act (5 ILCS 220/1 et seq.) authorizes units of local government to Illinois to exercise jointly with any other public agency within the State, including other units of local government, any power, privilege, or authority which may be exercised by a unit of local government individually and to enter into contracts for the performance of governmental services, activities and undertakings; and

WHEREAS, the CITY and FVPD wish to express their mutual desire for intergovernmental cooperation for the benefit of its neighborhoods and surrounding community within the CITY and FVPD boundaries; and

WHEREAS, the FVPD agrees to grant temporary construction access to the CITY on certain parcels located adjacent to the CITY'S Aurora Transportation Center (ATC) Regional Facility Enhancement Project (the "FVPD PARCELS") being parcel number 15-22-178-009; and the southern 100 feet of parcel number 15-22-178-001 and identified on the Location Map attached hereto as Attachment A; and

WHEREAS, said temporary construction access shall begin no earlier than January 1st of 2018 and shall extend no longer than July 1st of 2020; and

- NOW, THEREFORE, for the consideration of the mutual promises and undertakings set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:
- 1. <u>Incorporation of Recitals</u>. The foregoing recitals to this Agreement are substantive and are hereby incorporated into the Agreement as though fully set forth herein.

- 2. <u>Temporary Construction Access</u>. The FVPD hereby agrees to grant temporary construction access to the CITY on certain parcels located adjacent to the CITY'S Aurora Transportation Center (ATC) Regional Facility Enhancement Project (the "FVPD PARCELS") being parcel number 15-22-178-009; and the southern 100 feet of parcel number 15-22-178-001 and identified on the Location Map attached hereto as Attachment A:
 - a. Said access shall be granted on January 1st of 2018 and shall extend no longer than July 1st of 2020.
 - b. Upon completion of the construction work the CITY shall restore the area to its prior condition.
- 3. <u>Cooperation with Grant Applications</u>. To the extent not in conflict with any pending or proposed grant application by FVPD, FVPD shall cooperate and support by resolutions of endorsement any grant applications sought by the CITY provided, however, FVPD shall be a non-participating co-sponsor and not be obligated to bear any costs associated with such grant application.

IN WITNESS WHEREOF, the parties have set their hands and seals the day and year first written above and the signatories hereto represent that they are duly authorized to execute the Agreement on behalf of their respective bodies.
