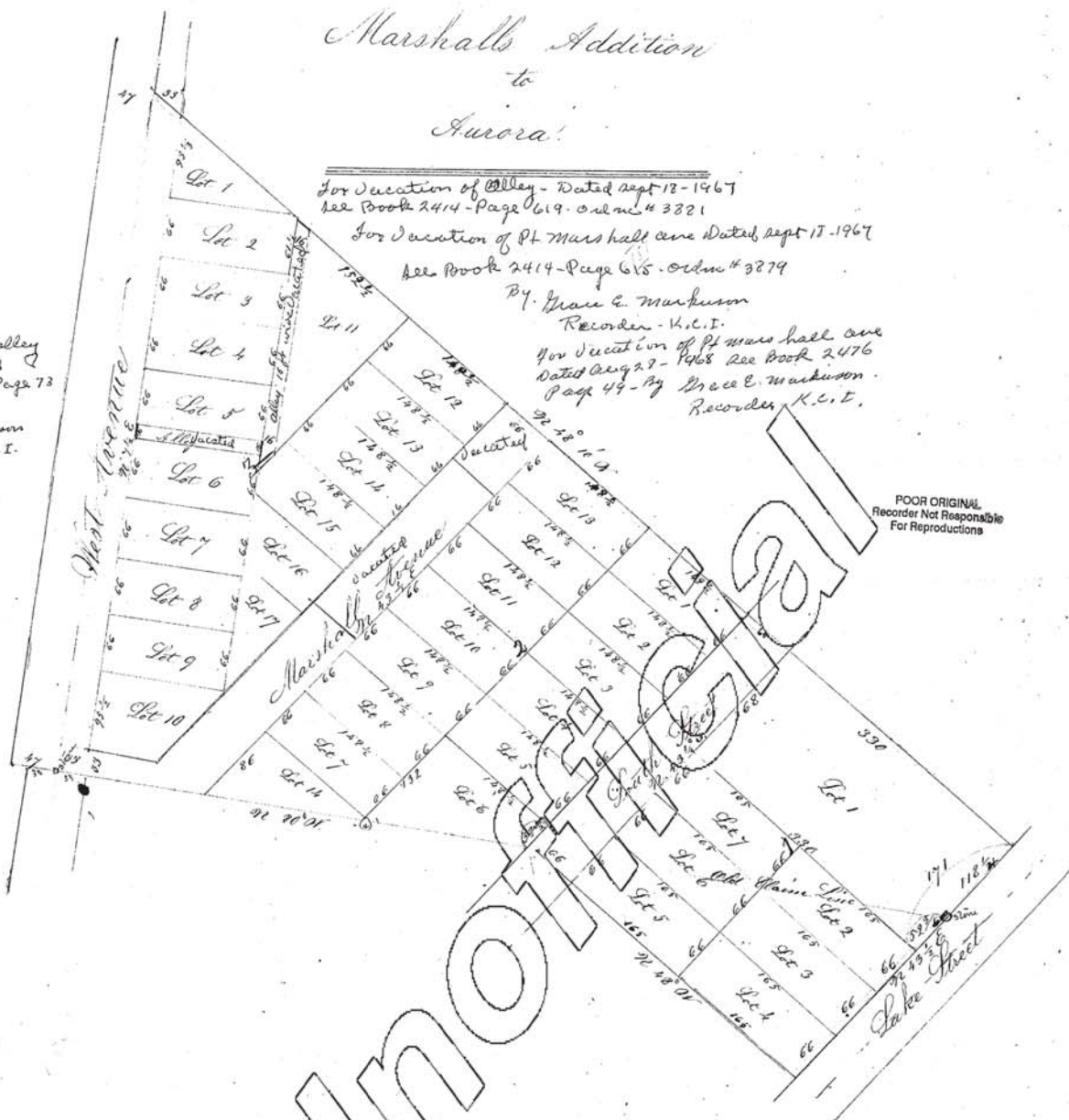

4 1/2 links off the Southwesterly side of Block 13 all in Holbrook's Addition to West Aurora, also another piece of land
bounded as follows To wit: Beginning at a stone on the westerly side of Lake Street where the southerly line of
Block 14 in Holbrook's Addition intersects the same thence S. 43 3/4 W. along the westerly side of Lake

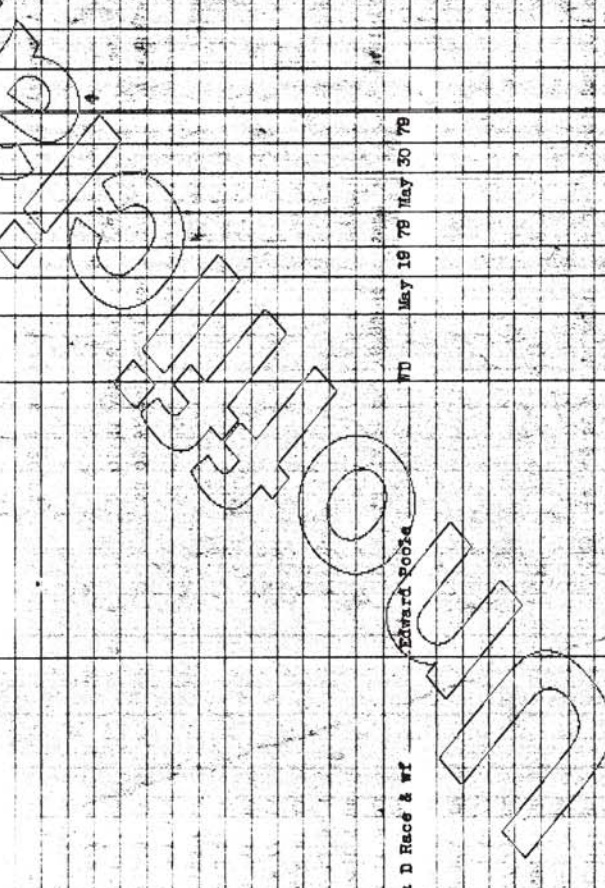
