Re: Aurora Well 8 Abandonment

Mr. Leible:

Per your request, it is Layne's pleasure to present this proposal to abandon the City's Well #8. If contracted, Layne will perform the work on a time and material basis per the attached Schedule B Work Order Form and will follow the terms and conditions of our Professional Services Agreement (PSA) with the City. The attached Work Order Form lists Layne's standard published rates. The estimates in this letter include the PSA stipulated 5% deduct applied toward labor.

The abandonment of Well No. 8 falls under the supervision of the Kane County Health Department (KCHD). Layne will coordinate all permit applications, abandonment per code, KCHD inspection notification, and final paperwork submittals to the KCHD with copies to the City. A preliminary discussion will be made prior to the commencement of the work to attain KCHD approval for the proposed method of well abandonment.

This proposal is based upon the following assumptions:

- Normal pump removal (i.e. no column separation)
- Torch cut of pump column pipe
- The proposal includes disposal of the Type H motor with a Certificate of Proper Disposal issued to the City.
- The proposal includes an Inspection Report of the discharge elbow, column pipe, motor, bowl, and cable with observations and recommendations as to these components' viability as City spare units
- Layne will dispose of components deemed unfit to utilize as spare equipment
- The abandonment will terminate at floor level in the facility's basement

The estimate to furnish all equipment and labor, and to furnish and properly install all well abandonment materials, is \$130,000.
