WHEREAS, New York Centre, LLC has completed the public improvements for said project; and

WHEREAS, these said improvements have been inspected during construction by the Engineering Department, or their authorized representative, and were found to be in substantial conformance with the approved plans; and

WHEREAS, the City Engineer has recommended acceptance of the improvements upon posting of a Maintenance Security in the amount of \$9,404.00

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, as follows: that these improvements be accepted upon receipt of a Maintenance Security in the amount of \$9,404.00
