- Aurora Police Department to provide Network information for each camera
- Aurora Police Department to provide a Network Port with POE for each camera
- Aurora Police Department is responsible for programming and configuring the cameras into Genetec
- Existing lighting in both rooms will be moved closer to the ceiling so it does not affect the field of view
