

1 Sec 27-168 Stopping, Standing Or Parking Prohibited

2 1. It shall be unlawful at all times to stop, stand or park a
3 vehicle in any of the following places:

4 1. Within any intersection;

5 2. On any sidewalk except during or within twenty-four (24)
6 hours after a snowfall specified under section 27-171,
7 subsection (a) and then only upon the driveway of a
8 residential premises, or on any crosswalk, ~~parkway or~~
9 ~~tree bank~~;

10 3. On the roadway side of any vehicle stopped or parked at
11 the edge or curb of a street;

12 4. In any place where such vehicle would reduce to less
13 than eighteen (18) feet the width of the roadway
14 available for use by moving traffic;

15 5. Alongside or opposite any street excavation or
16 obstruction if it would result in the obstruction of
17 moving traffic;

18 6. On any railroad tracks;

19 7. In any fire lane;

20 8. In any subway or upon any bridge or viaduct;

21 9. Between a safety zone and the adjacent curb, or within
22 twenty (20) feet of a point on the curb immediately
23 opposite the ends of a safety zone;

- 1 10. On that area of any front yard which lies as an
2 open space between the front lot line and the nearest
3 line of a principal building on that lot and which
4 extends across the full width of the lot; unless that
5 area has been covered with concrete, asphalt, blacktop
6 or otherwise improved with a permanent material and
7 commonly known as a driveway for automobiles;
- 8 11. At any place where official signs prohibit stopping.
- 9 12. On the roadway side of any vehicle stopped or parked
10 at the edge or curb of any street (double parking);
- 11 13. In such a manner as to occupy more than one (1)
12 adjoining parking space or encroaching in any way into
13 an adjoining parking space (occupying more than one (1)
14 parking space);
- 15 14. Parking on any public street, alley or in any
16 parking facility, regardless of whether signs are posted
17 or not, for forty-eight (48) continuous hours unless a
18 valid parking permit issued by the city is properly
19 displayed in said vehicle.
- 20 2. Except while momentarily engaged in the pickup or discharge
21 of passengers, it shall be unlawful to stop, stand or park a
22 vehicle or any part thereof in any of the following places:
- 23 1. In front of, or within five (5) feet on either side of,
24 a public or private driveway;

- 1 2. At any curb within fifteen (15) feet of a fire hydrant;
- 2 3. Within twenty (20) feet of any crosswalk;
- 3 4. Within thirty (30) feet of any flashing signal, stop
- 4 sign or other traffic-control signal located at the side
- 5 of a roadway;
- 6 5. Within twenty (20) feet of the driveway entrance to any
- 7 fire station and, on the opposite side of the street,
- 8 within seventy-five (75) feet of such an entrance;
- 9 6. Within ten (10) feet of any mail box, Monday through
- 10 Saturday between the hours of 8:00 a.m. and 6:00 p.m.,
- 11 except on postal holidays. (Exemption: This section
- 12 shall not apply to residents parked in front of their
- 13 mailbox only).
- 14 7. At any place where official signs prohibit standing.
- 15 3. Except while temporarily engaged in the act of loading or
- 16 unloading merchandise or passengers, it shall be unlawful to
- 17 stop, stand or park a vehicle in any of the following places:
- 18 1. Within fifty (50) feet of the nearest rail of a railroad
- 19 crossing;
- 20 2. At any place where official signs prohibit parking,
- 21 unless a valid parking permit issued by the city is
- 22 properly displayed in said vehicle.

1 4. No person shall move a vehicle not lawfully under his control
2 into any such prohibited area or away from a curb such a
3 distance as is unlawful.
