- Our pricing is based upon completing all work in the 2018 construction season, unless otherwise noted, and is based upon material and cartage
 rates in effect at the time of this proposal. Due to the volatility of the petroleum market, our proposal is subject to adjustment, based upon the
 market price and availability of raw materials and cartage rates at the time of installation.
- We have included (1) mobilization to complete our work.
- NIC- Furnishing of payment and performance bonds, permits, backfilling or landscape restoration work along new pavement edges, structure adjustments, prime coat over stone, sweeping, cleaning or application of tack coat between paving lifts.
- Taxes on materials has NOT been included in our pricing.
- Builders Paving, LLC will not be responsible for any damage or claims due to unmarked, uncharted or incorrectly located utility or other underground installations. All installations must be properly located by others, both horizontally and vertically, prior to our performing our work.
- If subsurface or latent physical conditions are encountered that differ materially from those indicated by the plans, specifications or other project
 documents that we are in possession of, or from those conditions that could be reasonably anticipated, and these conditions affect the cost and/or
 time required to perform the contracted work, then the contract price and/or time of completion shall be adjusted accordingly.
- It is expressly understood that Builders Paving, LLC will not knowingly perform any work that would subject any persons to undue safety or health hazards or that would create any safety or health hazards now or in the future. If special waste or hazardous materials, or any other deleterious materials are encountered, and/or any conditions or situations occur that require any special personal protection devices, and/or any special shoring, handling, treatment, decontamination, removal and/or disposal in order to comply with this prerequisite, then, all work of this sort and under these conditions or situations will be performed in compliance with all applicable rules, regulations or ordinances currently in effect, strictly as an extra to the contract on a cost-plus-fee basis, and the contract price will be adjusted accordingly.
- The above items and our standard terms of payment and insurance coverages strictly define this proposal. Should conflict with the plans, specifications or other project documents arise, this proposal shall take precedence.
- The subcontractor has a right to an equitable price adjustment in case of delays, accelerations, out-of-sequence work and schedule changes beyond
 its reasonable control, and can terminate the subcontract in case such events delay work by more than 90 days.
- NIC Additional testing costs associated with Clean Construction and Demolition Debris (CCDD) Regulations, which require uncontaminated soil
 certification of construction spoils before they can be hauled to and accepted at a legal dump.

- All roadway and pavement construction to be installed per IDOT Standard Specifications for Road & Bridge Construction, latest edition.
- This proposal is valid for a period of thirty (30) days from the date of issue and may be revised or rescinded thereafter, at our discretion, without prejudice.
