## Scope:

- 1. Furnish and install (2) 3' x 5' HH's with locate pedestals. One at McCoy and one outside of the Water Plant located at 3244 Richard Ct.
- 2. Furnish and install approx. 3100' of 1.25" polyduct from HH 22-6 to the fiber entry point at 3244 Richard Ct. and through each of the (2) newly installed HH's.
- 3. Furnish and install approx. 3500' of 48ct outdoor SMF from HH 22-6 to the FDP leaving 100' slack loops at each HH.
