Mr. Ragona introduced himself as the City of Aurora, Community Development Division Manager. He introduced the Community Development Division staff and Block Grant Working Committee member.

Mr. Ragona opened the public hearing at 1:04 p.m. for Substantial Amendment 2020-#2

Mr. Ragona stated the purpose of this public hearing is not to discuss or respond to specific questions regarding the Substantial Amendment. The purpose of this public hearing is to obtain public input for the City Council in their deliberation of the Amendment and to HUD on the proposed Substantial 2020-#2 recommendations to the City's 2016, 2017, 2018, 2019 and 2020 Annual Action Plans. Public input will be provided to the City Council in their consideration of the funding recommendations and Annual Action Plan Substantial Amendments and will be included in the amended Action Plans submitted to HUD.

Mr. Ragona reviewed the Substantial Amendment 2020-#2's public notification process which included posting in the in the *Reflejos* and *The Beacon News* newspapers and on the City's website. The notice requested that those wishing to provide public comments pre-register with the Community Development Division no later than 12:00 noon on July 29, 2020. The public hearing notice also advised that upon advance request, the City would provide translation services to meet the needs of non-English speaking residents. On July 27, 2020, a summary of the proposed Substantial Amendments to the City of Aurora's 2016, 2017, 2018, 2019 and 2020 Annual Action Plans was made available for review and public comment on the City of Aurora's website.

Mr. Ragona read the public notice as posted in *The Beacon* newspaper (Public Notice attached).

Mr. Ragona also provided a brief overview of Substantial Amendment 2020-#2, and highlighted the following funding adjustments made to accommodate the Substantial Amendment 2020-#2 CDBG, CDBG-CV, and HOME activities.

Mr. Pilmer highlighted the importance of the Walters Park Wellness Walk and asked the City of Aurora to remain committed to the urgency of this project and direct the committed CDBG funding to the project as soon as funds are available.

Mr. Ragona stated that the comment period extends through August 3, 2020, 4:00 p.m. The City of Aurora will include a summary of all comments together with the City's response(s) in the City's submittal of the Substantial Amendments to HUD. It is anticipated that the City Council will make a final determination for approval of Substantial Amendment 2020-#2 on August 11, 2020.

Annual Action Plan Substantial Amendment (2020-#2)

As an entitlement community, the City of Aurora, Illinois ("City") receives funding from U.S. Department of Housing and Urban Development (HUD) through the Community Development Block Grant Program (CDBG), HOME (HOME) Investment Partnerships Program, and Emergency Solutions Grant (ESG) Program. Through the March 27, 2020 passage of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136, the City has also received a CDBG-CV allocation. To expedite the disbursement of the City's 2019 CDBG, 2020 CDBG, 2020 CDBG-CV, and 2016, 2017, 2018, and 2019 HOME funds, via 24 CFR 5.110, the CARES Act authorizes HUD to grant waivers to the public notice, public comment, and citizen participation plan requirements found in 24 CFR 91.105I(2) and (k), 24 CFR 91.115I(2) and (i) and 24 CFR 91.401. In accordance with the City of Aurora's Citizen Participation Plan and HUD's regulatory requirement waivers (which reduce the minimum 30-day public comment period to a 5-day period), a virtual public hearing will be held at 1:00 p.m. on July 30, 2020 to provide an opportunity for comment on the City's proposed *Substantial Amendment (2020-#2)* to its *2016, 2017, 2018, 2019 and 2020 Annual Action Plans*. The Substantial Amendments will result in the re/allocation of unexpended CDBG, CDBG-CV and HOME funds and adjustments needed to ensure the integrity of the City's spending obligations and to also further address the City's effort to comply with HUD's regulatory requirements in administering the City's CDBG and HOME Programs.
