We working with the Muscular Dystrophy Association in Downers Grove and have applied for necessary insurance policies for this event.

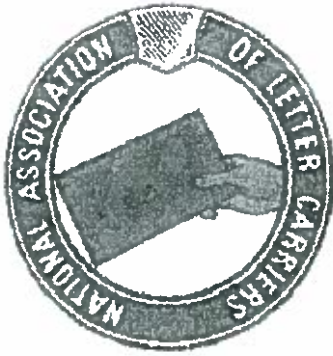
