### RESOLUTION NO. R20-272 DATE OF PASSAGE Wovember 24,2020

A Resolution Renewing All Fees Pertaining to Chapter 46 of the City of Aurora Code of Ordinances Entitled "Towing Services".

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, it is appropriate for the City of Aurora to amend the fees related to the tow list and the maximum tow fees charged by any towing operator in the City of Aurora, when removing a vehicle from the street in response to a police call, as well as the maximum storage charges for any such towed vehicles.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Aurora, Illinois, as follows: upon passage of this Resolution, pursuant to Chapter 46, R19-008 is hereby repealed and replaced with "Exhibit A" pursuant to Chapter 46, Sec. 46.65., all previous rates pertaining to Sec. 46.65 are hereby repealed and replaced with "Exhibit A" effective January 1, 2021.
