Sealed Bid Proposals will be received at the City of Aurora, Purchasing Division, 44 East Downer Place, Aurora, Illinois 60507-2067 until 2:00 p.m., Wednesday, October 28, 2020, to determine proposals for the anticipated purchase of professional services in compliance with City Code Ordinances (Utilities: Responsibility for installation, maintenance) 48-26 for plumbing services for property owners within the City of Aurora, Illinois. . Proposals will be opened and read publicly via a non-mandatory teleconferenced and live streamed proposal opening at 2:00 P.M., Wednesday, October 28, 2020, access details will be posted to the city's website.

Scope of work includes the Contractor providing plumbing services to maintain and repair water service pipes that are leaking, curb box and cock, meters and valves from the water main to the water meter of property owners. These services do not include total replacement of water service due to inaccessibility, i.e. stoops, porches and/or slabs. The City intends to enter into contract with a maximum of twelve (12) qualified and responsible Contractors for such services. The contract shall be for the period January 1, 2021 thru December 31, 2021.
