Tax Imposed: A tax is hereby imposed upon the retail purchaser of gas in the City of Naperville, which is purchased in a sale at retail, at a rate of 0.04 cents per therm, and shall be known as the municipal gas use tax. The tax shall apply to gas for which the delivery to the retail purchaser is billed by a public utility on or after September 1, 2008.</p>
