 1. Provide a conspicuously mounted portable fire extinguisher for each 500 square feet of tent.
 2. No Smoking signs shall be conspicuously mounted.
 3. No open flames, fireworks, heating appliances or cooking shall occur in or within 20 feet of the tent.
 4. Cords shall be provided with mechanical protection and arranged to minimize tripping hazards.
 5. Temporary lighting shall comply with Article 525 of the NEC.
