Scope of Work

Contractor shall provide the Services and Deliverable(s) as follows: Reconfigure 2 recording cores, 1 at Aurora PD and 1 at AFD. The reconfiguration will remove the analog CAMA trunk 911 twisted pair wires from the 66-telephony block. Any resources that reside BELOW the CAMA trunks on the telephony block will be disconnected and moved UP the block to fill in where the CAMA trunks were. New SIP trunks are being configured by AT&T and will hand-off to WSI via span ports on the AT&T or Client provided managed network switches. AT&T will provide a list of IP addresses for WSI to target to record the ESInet SIP trunk audio traffic. WSI will be stopping the recording services and will be removing all power from the existing "temporary" servers for a period of 4 to 8 hours. The database and all previously recorded audio will be migrated from the "temporary" servers to new servers provided by the City of Aurora.

Client Responsibilities

- Provide IP address information for the target SIP trunks
- Provide access to each of the NICE servers as needed by WSI field personnel
- Facilitate vendor meetings with 3rd party vendors as needed
- Provide new servers to replace the "temporary" servers that are in place currently
- Help to manage the down time of each server by routing calls to backup site or mitigating loss of recording services by implementing any emergency or maintenance protocols are in place for loss of service.
