The low base bid was submitted by Artlip and Sons, Inc. from Aurora, IL in the amount of \$508,000.00. The second lowest base bid was submitted by MG Mechanical Contracting, LLC from Woodstock, IL in the amount of \$589,000.00. See attached bid tabulation for details on bid results. Alternate Bid No. 1 was also included in the amount of \$156,500.00 and \$184,000.00 respectively.
