Advocate Health Care is the largest fully integrated not-for-profit health care delivery system in Illinois and is recognized amongst the top systems in the country. We are proud to be Illinois based and Chicago born and bred. More than 170 of our over 250 sites of care are in the City of Chicago. The geographic reach of Advocate is unparalleled and unlike other vendors. Advocate has eight occupational health sites in the Chicago land area with physician's board certified in occupational health and family medicine, and has access to the state's largest physician network or primary care, specialty and sub-specialists.

Advocate is an organization of physicians, nurses and health care professionals dedicated to serving the health needs of individuals, families and employers. Advocate operates more than 250 sites of care, including 11 acute care hospitals, two integrated children's hospitals, five level I trauma centers (the state's highest designation in trauma care), a home health care company and the region's largest medical group. Recognized as one of the top 10 places to work in Illinois, Advocate is one of Chicago land's largest employers with more than 6,000 affiliated physicians, including 3,800 in physician hospital organizations (PHOs) and 1000 employed physicians, 9,000 nurses and more than 33,000 associates. More than \$474 million in charitable care and services were contributed to neighborhoods across Chicago land in 2012.

AOH provides services to the six-county Chicago market with eight locations. Our centers are full service health care facilities, with sites focused in the specialty of Occupational Medicine. Employers rely on our expertise for post-offer and annual physicals and related screenings. Our staff has extensive experience providing DOT mandated physicals, drug screening, and breath alcohol screening. AOH offers employers a DOT consortium to address their random screening needs. In addition, we provide a high quality, cost-effective approach to the treatment of occupational injuries, illness, and follow up care.

AOH Centers have been performing physicals since 1984. Our centers serve some of the area's largest municipalities and employers. Currently, Advocate Occupational Health provides medical services for over 2,800 clients.



Scope of Services

Physical Examinations

Advocate Occupational Health offers physical examinations geared toward assisting you in hiring and maintaining a safe and healthy work force. Physicals included are post-offer employment, DOT, respirator clearance, back assessment, executive, annual, and fitness for duty. The flexibility of our program allows us to work with you to meet the specific needs of your company. Appointments are not necessary but are available if wanted. We provide screening and testing to help you satisfy medical requirements and assure the health and safety of your employees. All physicals require medical staff including a physician to examine each individual thoroughly. We currently provide physicals for municipalities, manufacturing industry, business executives and regulatory positions.

Occupational Injury Treatment

As your health care partner we work with you to reduce the costs associated with work-related injuries and illness. If applicable our medical staff will tour your company to gain an understanding of the tasks your employees perform. We then work with you to keep injured employees active in the workplace through your light duty program. Our aggressive treatment plans reduce the number of visits and recovery time while eliminating over-treatment. You are kept informed through physician phone calls after the initial visit and follow-up written reports. Our physicians are available to you if you ever have questions. Advocate Occupational Health is a preferred provider with most workers' compensation insurance carriers. With 12 occupational health centers, 11 local hospitals, and over 20,000 affiliated physicians, Advocate has the resources to assist your company with any health-related issue.

Drug and Alcohol Screenings

Substance abuse services can be performed as post accident, random or as part of the post offer exam. A variety of tests are processed at a NIDA/DHHS and SMHSA certified laboratory – Clinical Reference Laboratory. All testing follows strict Department of Transportation (DOT) guidelines. Staff members are certified in performing breath alcohol testing and drug screen collection. Our Assistant Medical Director is a Certified Medical Review Officer and reviews all drug screen results for accuracy. Breath alcohol testing is done using the latest equipment which is calibrated regularly.

Advocate offers random selection services for your drug/alcohol screening program. Our consortium for commercial drivers meets the standards set by the Department of Transportation. We can assist you in developing a customized program for the specific needs of your company.



Other Testing

Advocate Occupational offers a full line of ancillary testing such as audiometric, pulmonary function, immunization services, lead testing, respirator mask fit testing, electrocardiogram and other various blood testing.

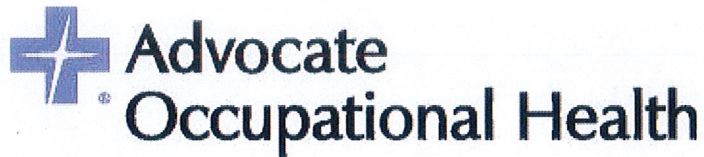
Additional Services provided to employers through Advocate Health Care include:
