Mr Baker,

Thank you for the opportunity to submit the following proposal for the project referenced above.

Scope

- 1. Julie proposed path and mark utilities.
- 2. Engineer the Orchard and Jericho intersection.
- 3. Furnish and install approx. 7200' of 1.25" poly with tracer and (5) HH's from existing HH at the southwest corner of Orchard and Jericho, to the Habitat for Humanity property.
- 4. Furnish and install approx. 7700' of FOC cable in the newly installed poly leaving 50' slack loops in each of the HH's along the route.
- 5. Furnish and install new splice case at the Orchard HH and perform midsheath of the cable.
- 6. Furnish and install new splice at the HH outside of the Habitat property and prep new cable into the case.
- 7. Furnish and install new splice at the HH outside of 1440 Jericho Rd and prep new cable into the case.
- 8. Provide fusion splicing of TBD fibers at the Orchard Rd HH.
- 9. Create new SEP's for (6) HH locations.
- 10. Test newly spliced fibers and turn in test results package.
- 11. Provide As-builts of intersection and path upon completion.
- 12. Restoration of disturbed turf to be seed and blanket.
