Use of Parks and Public Spaces

- "The right to the use and enjoyment of a park is a valuable right; anyone who is wrongfully deprived of its use may maintain an action to restrain his or her exclusion." Quinn v. Irving Park District, 207 III.App. 449 (1st Dist. 1917).
- Restrictions on access and use must comply with the First Amendment



First Amendment

Freedom of speech, religion, assembly





Type of Speech

- Written
- Spoken
- Symbolic





Type of Public Forum

- Traditional Public Forum
 - Places that are traditionally used for assembly, debate and other "expressive activities"



Type of Public Forum

Designated Public Forum

 A nonpublic forum that is not historically open to speech- and assembly-related activities but that the government agency has purposefully opened up for public dialogue on a limited or permanent basis



Type of Public Forum

- Limited Public Forum
 - Speech restrictions need only be reasonable and viewpoint neutral
 - Nonpublic forum



Content Neutrality

Regulations on speech in traditional and designated forums must withstand scrutiny

- "content-based"
- "content-neutral"
- issue to avoid: prior restraint



- Most likely to be in a park/street/sidewalk which is likely to be considered a traditional public forum
- Ok to place content neutral restrictions on:
 - o Time
 - Place
 - Manner
- NO viewpoint based regulations
- Coordinate with EAP and safety



Occupy Chicago Example

- Chicago Park District sought to enforce a provision of the Chicago Park District Code which prohibits people in Chicago Parks from 11 pm to 6 pm.
- Several Occupy Chicago protesters were arrested for being in Grant Park after-hours
- Protesters challenged their arrest, claiming that the ordinance violated their First Amendment Rights.
- The Appellate Court and Illinois Supreme Court upheld the ordinance as a constitutional, content neutral restriction.



LESSONS FROM RELIGIOUS DISPLAYS:









Public Religious Displays

- First Amendment
 - Freedom of Religion
 - The Establishment Clause
 - Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof.
- Government Speech Doctrine



Private Holiday Displays on Public Property

- Is the speech protected by the First Amendment?
- What is the public forum and how can the government limit access in that forum?
- Are there any justifications for exclusion from the forum?



Private Holiday Displays on Public Property

- Traditional or designated public forum
 - Reasonable time, place, and manner regulations
 - Content neutral
- Limited or nonpublic forum
 - Viewpoint neutral



2 GROUPS OF FESTIVALS

- GOVERNMENT SPONSORED
 - Government speech doctrine applied to space
 - Total control, but need for pressure relief valve

- PRIVATELY SPONSORED (RENTAL)
 - Content neutral on rentals
 - Consistent rental terms including safety
 - Best Practice: Require EAP for every rental

| How to report emergencies | Escape routes & procedures |



Planning

Stakeholders: Police, Fire, Event Organizers, Volunteer coordinators, Contracted Parties, Bands, Attractions



Hardening the Festival Space

- Traffic and barricades
- Gate Surveillance and Procedures
- Manpower allocations
- Command Post
- Intelligence sharing



Incident Plan

- Staffing and Command
- Communications/technology
- Exiting from the Event



Post-Festival

Debrief and Lessons Learned



Designate a Space for Speech Acts

- Put in Plan for Every Private Festival
- Space Inside and Outside Event
 - Ticketed events
 - Solution on Civil Disobedience
- Require Signage



Permitting (and prior restraint)

- Brief time frame for review and issuance
- Specific, content-neutral approval criteria
- Consistent enforcement
- Consistent requirements on Planning and Insurance for Renters
- Retain final authority



Civil Disobedience

- Camera Phones
- De-Escalation where possible
 - Individual officer discretion on force
 - Filmed speech of various alternatives
 - Variety of enforcement tools available
 - fine
 - removal
